

2. Riverbank Care and Safety


Audit of Town's Banks – Aug 2015

- Major bank degradation in specific areas due to boat wash and natural factors.
- Trees and parts of bank are being compromised and need urgent remedial action – Bank Stabilisation
- Footpath unsafe due to 4 metre sheer drop where bank has fallen away.
- Height markers on Ravo bridge are required
- Safety lighting is required under the bridge

River Bank Erosion - Walkway




Undermining of western Power pole due to river bank erosion

View of western Power Pole from cycle/walking track. 1m to open face with a fall of 4m and <u>no</u> safety guarding.



Solution/s??

- Relevant Authority rectify issues of bank erosion build retaining
- Relevant authority take immediate steps to remediate high risk areas that are sensitive to bank erosion.

OR

- Adjacent land holder remediate or erosion proof their bank.
 - - adjacent land holder has any tenure over the jetty but not the land between their Title and the Jetty.

OR

• DO NOTHING - - the bank will erode on the susceptible areas – sheer dropoffs will be the result – loss of trees – environmental impacts that are avoidable.
